YKK Thailand has played a significant role in the development of Thailand's garment and bag industries, in particular through the transferring of advanced technology and know-how from our operations in Japan.



As a responsible supplier of YKK zippers, our anticounterfeit measures will always be focused on protecting our customers and consumers. We believe it is crucial to maintaining the brand value of YKK to our current and future customers.

Tackling the problem

Counterfeit zippers are primarily produced in Asian countries, exported to ASEAN and South Asia, sewn into clothes there, and then re-exported to markets in the US, Europe and Japan.

As such, we have been working with the relevant authorities since 1993 by taking legal action such as conducting market raids, customs seizures and filing civil suits where applicable. YKK is also committed to taking action in consuming countries with the cooperation of respective brand owners.
